Step 1. Complete and forward forms to NSW Office of State Revenue.

- Complete the Clearview Managed Investments - Transfer of Ownership Form with details of the transferor(s)/seller(s) and transferee(s)/buyer(s).
- Lodge the Clearview Managed Investments - Transfer of Ownership Form with the NSW Office of State Revenue.

Please contact the NSW Office of State Revenue to confirm payment amount and payment methods.

Do not send money to ClearView as payment for stamp duty.

iii) Await NSW Office of State Revenue to complete the Clearview Transfer of Ownership Form.

This form must be stamped by, and bear the imprint of, the Stamp Duties office stamp (this includes transfers by way of a gift). This stamp shows the stamp duty paid or the exemption received from the Office of State Revenue.

Step 2. NSW Office of State Revenue returns the Clearview Transfer of Ownership Form.

- Once the Office of State Revenue completes your lodgement, mail the following to ClearView:
 - Stamped ClearView Managed Investments - Transfer of Ownership Form; and
 - Completed Application Form (located in the Product Disclosure Statement).*

* The Application Form only needs to be completed where the units are not being transferred to an existing investment in the ClearView Managed Investments.
